



Notice to Update Claim Information

The U.S. Victims of State Sponsored Terrorism Fund (“USVSST Fund”) requires all applicants to update claim information, as necessary, in a timely fashion pursuant to an applicant’s continuing obligation and certification on the Application Form. An applicant must provide the USVSST Fund information regarding:

- Compensation from any source other than the USVSST Fund that the victim, or the victim’s beneficiaries, received or is entitled to receive. An applicant is obligated to inform the USVSST Fund of any compensation not previously disclosed. Sources of compensation other than the USVSST Fund include, but are not limited to, life insurance; pension funds; death benefit programs; payments by federal, state, or local governments; and court-awarded compensation related to the act that gave rise to the judgment. This also includes any award or award determination an applicant has received under either the September 11th Victim Compensation Fund of 2001 (“VCF1”) or the James Zadroga 9/11 Health and Compensation Act of 2010 (“VCF2”). *See* frequently asked question (FAQ) 4.6, available on the USVSST Fund website at <http://www.usvsst.com/faq.php>.
- Change of address or other contact information for any individual identified in the Application Form. If there is a change of counsel, the applicant must submit the necessary forms, available on the USVSST Fund website at <http://www.usvsst.com/forms.php>.
- Any changes in payment information. Please review the previously submitted ACH Payment Form and if there are any corrections needed for deposit of subsequent distribution(s), submit an updated ACH Payment Form, available on the USVSST Fund website at <http://www.usvsst.com/payment.php>.
- Significant developments involving the final judgment or other facts affecting eligibility.
- Any changes in Personal Representative(s) or a previously approved proposed distribution plan, including if a Personal Representative or beneficiary under a distribution plan is now deceased.
